SURVEYORS (REGISTRATION AND ADMINISTRATION)

(AMENDMENT) REGULATIONS 2019

In exercise of the powers conferred by section 19 of the Surveyors Ordinance 1960 [No. 22 of 1960], the Surveyors Board with the approval of the State Secretary, makes the following regulations:

### **Citation and commencement**

1. (1) These regulations may be cited as the Surveyors (Registration and Administration) (Amendment) Regulations 2019.
- (2) These Regulations come into operation on the date of its publication in the *Gazette*.

### **Amendment of regulation 7**

2. The Surveyors (Registration and Administration) Regulations 1989 [G.N.S. No. 9 of 1989], is amended in regulation 7 –

- (a) by deleting the word “and” at the end of paragraph (b);
- (b) by substituting for the fullstop the words “; and” at the end of paragraph (c); and
- (c) by inserting after paragraph (c), the following paragraph:
  - “(d) notwithstanding paragraph (a), (b) and (c), survey works issued under Engineering Survey Paper shall be payable up to 95% of the fee upon submission of the completed survey works to the client.”.

(AMENDMENT) REGULATIONS 2019

In exercise of the powers conferred by section 19 of the Surveyors Ordinance 1960 [No. 22 of 1960], the Surveyors Board with the approval of the State Secretary, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the Surveyors (Conduct of Topographical and Engineering Surveying) (Amendment) Regulations 2019.
- (2) These Regulations come into operation on the date of its publication in the *Gazette*.

**General amendment**

2. The Surveyors (Conduct of Topographical and Engineering Surveying) Regulations 2017 [*G.N.S. No. 6 of 2017*], hereinafter referred to as the “principal Regulations” in these Regulations, is amended in substituting for the word “leveling” wherever appearing the word “levelling”.

**Amendment of regulation 14**

3. Section 14 of the principal Regulations is amended –

(a) in subregulation (1), by substituting for the words “barks” the word “marks”; and

(b) in subregulation (2), -

- (i) by substituting for the word “ $\pm (20vk)$ ” the word “ $\pm (20\sqrt{K})$ ”; and
- (ii) by substituting for the word “*k*” the word “*K*”.

**Amendment of regulation 19**

4. Subregulation 19(2) of the principal Regulations is amended by substituting for the word “Regulation” the word “regulation”.

**Amendment of name of Chairman**

## SURVEYORS ORDINANCE 1960

SURVEYORS (CONDUCT OF UNDERGROUND UTILITIES SURVEYS)  
(AMENDMENT) REGULATIONS 2019

In exercise of the powers conferred by section 19 of the Surveyors Ordinance 1960 [No. 22 of 1960], the Surveyors Board with the approval of the State Secretary, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the Surveyors (Conduct of Underground Utilities Surveys) (Amendment) Regulations 2019.
- (2) These Regulations come into operation on the date of its publication in the *Gazette*.

**Amendment of regulation 14**

2. The Surveyors (Conduct of Underground Utilities Surveys) Regulations 2017 [G.N.S. No. 7 of 2017], hereinafter referred to as the “principal Regulations” in these Regulations, is amended in subregulation 14(2) –
  - (a) by substituting for the word “leveling” the word “levelling”; and
  - (b) in paragraph (b), by substituting for the words “ $\pm$  (20vK)mm” and by substituting for the word “Kilometres”, the words “ $\pm$  (20K)mm” and “kilometres” respectively.

**Amendment of regulation 21**

3. The principal Regulations is amended by substituting for regulation 21 the following section:

**“Submission of the survey plans and records”**

21. A copy of the final report, utility survey plan(s) and digital survey data shall be extended to the Director.”.

**Amendment of regulation 22**

4. Regulation 22 of the principal Regulations is amended –
  - (a) by inserting after the words “survey plan” the words “submitted to the client”; and
  - (b) by inserting after the words “represents the survey” the words “up to Confidence Level.....”.

In exercise of the powers conferred by section 19 of the Surveyors Ordinance 1960 [No. 22 of 1960], the Surveyors Board with the approval of the State Secretary, makes the following regulations:

**Citation and commencement**

- (1) These regulations may be cited as the Surveyors (Conduct of Hydrographic Surveys) (Amendment) Regulations 2019.
- (2) These Regulations come into operation on the date of its publication in the *Gazette*.

**General amendment**

- The Surveyors (Conduct of Hydrographic Surveys) Regulations 2017 [*G.N.S. No. 8 of 2017*], hereinafter referred to as the “principal Regulations” in these Regulations, is amended in substituting for the word “leveling” wherever appearing the word “levelling”.

**Amendment of Title**

3. The principal Regulations is amended in the Title, by substituting for the word “HYDROGRAOHIC” the word “HYDROGRAPHIC”.

**Amendment of regulation 2**

4. Regulation 2 of the principal Regulation is amended by substituting for the definition of “Mean Sea Level” the following definition:

‘ “Mean Sea Level” means the average height of the surface of the sea at the tide station for all stages of the tide over a nineteen year period, usually determined from hourly height readings measured from a fixed predetermined reference level;’.

**Amendment of regulation 12**

5. Subregulation 12(2) of the principal Regulations is amended by substituting for the word “MSL” the word “Mean Sea Level”.

**Amendment of regulation 13**

6. Subregulation 13(2) of the principal Regulations is amended –

- (a) by substituting for the word “ $\pm 20 \text{ vK}$ ” the word “ $\pm (20 \sqrt{\text{K}})$ ”; and
- (b) by substituting for the word “k” the word “K”.

**Amendment of regulation 20**

7. Subregulation 20(1) of the principal Regulations is amended by substituting for the word “100%” the word “50%”.

**Amendment of regulation 27**

8. Regulation 27 of the principal Regulations is amended by inserting after the word “survey plan” the word “submitted”.

**Amendment of name of Chairman**
